The Annual General Meeting shall be called no later than 30 November of each calendar year.

The Secretary shall circulate all motions submitted to him together with the agenda for the Meeting and the audited financial statements of the KwaZulu Natal Sports Confederation to all Members per registered post and/or telefax and/or electronic mail not less than fourteen (14) days prior to the Annual General Meeting.
